## Trustee Election Results, 2016:

Whereas, current third Trustee position formerly held by Winter Green Development Corporation,

Whereas, Winter Green Development Corporation sold all lots on our about 2012 to T&S Investments owned by Tim & Steve Reinhold for \$1, and

Whereas, said buyer re-sold those lots to F&M Construction and

Whereas original Winter Green Development has abandoned Winter Lake Estates and Winter Lake Estates II by failing to attend mandatory meetings in 2014, 2015 and 2016 thereby confirming abandonment, and

Whereas Winter Green Development has not repaired or replaced assets while still Party of First Part, and by causing an election of a third Trustee, Winter Lake Estates Homeowners' Association.

## Be it resolved that:

- The Board directed and confirms the election of a third trustee during its 2016 Annual Meeting on November 14, 2016,
- Ms Sarah Ishmael of 146 Winter Lake Blvd, was elected as a Trustee by majority vote at the 2016 Annual meeting represented by 91 homeowners significant, which is approximately 63% of active, eligible homeowners. In the election Ms Ishamael received 100% of the 89 votes cast.
- 3. Duly elected in accordance with the Winter Lake Estates Indentures, and accepted by a majority of current trustees (Robin Reichardt and Dom Bausano both voting "yes"), the Winter Lake Estates Homeowners' Association welcomes Ms Sarah Ishmael as a full-fledged Trustees with the Rights, Responsibilities and Authority as defined by The WLE Indentures and Operating Agreement.

This letter is to confirm that I attended the Winter Lake Estates Homeowners Association annual meeting held on Monday, November 14, 2016 at 7pm at George Guffey Elementary School in Fenton, Missouri.

At the meeting noted above, votes were taken for appointment of a new trustee. There was one candidate brought forward. That candidate was Sarah Ishmael of 146 Winter Lake Blvd.

To reach a quorum we required at least 46 votes either in attendance or by proxy. We exceeded that by having 91 homeowners in attendance or by proxy. The breakdown of the ballots cast was 40 in attendance and 51 by proxy vote for a total of 91 votes for the candidate, Sarah Ishmael. There were no dissenting votes, therefore unanimous consent.
